The Bidder, in compliance with your invitation for bids for the **Fruitvale ISD-Administration Building and Junior High Parking Lot – Metal Building** and, having examined the plans and being familiar with all of the conditions surrounding the construction of the proposed project including the availability of materials and labor, hereby proposes to furnish all labor, materials, and supplies; and to construct the project in accordance with the Contract Documents, within the time set forth therein, and at the prices stated below. These prices are to cover all expenses incurred in performing the work required under the Contract Documents, of which this proposal is a part.

Bidder hereby agrees to commence work under this contract on or before a date to be specified in the Standard Agreement for Construction Services of the OWNER and to fully complete the project as stated within said Agreement. Bidder further agrees to pay liquidated damages also stated within said Agreement.

It is agreed that lump sum prices may be increased to cover additional work ordered by the ENGINEER, but not shown on the plans or required by the specifications, in accordance with the provisions of the General Conditions. Similarly, they may be decreased to cover deletion of work so ordered.

Unit price amounts shall be shown in both words and figures. In case of discrepancy, the amount in words shall govern. Totals shown in figures for each item are to be used to determine the apparent total bid amount at the time bids are opened. They are not to be used to determine the official bid amount. The official bid amount is determined as described below.

The total base bid amount shown in figures in parenthesis above is to facilitate the OWNER in determining the apparent low bidder at the bid opening. It is in no way provided to determine the official bid amount. The official bid amount, for unit price contracts, shall be determined by multiplying the unit price written in words by the respective quantity shown in the bid proposal and totaling those amounts. **The official bid amount shall be determined using this method, by the OWNER when the bids are tabulated.**

Bidder understands that the OWNER reserves the right to reject any or all bids and to waive any informalities in the bidding. Bidder also understands that the OWNER reserves the right to award the contract to the lowest responsive, responsible bidder according to the base bid amount or any of the alternate bid amounts.

Bidder agrees that this bid shall be good and may not be withdrawn for a period of 60 calendar days after the scheduled closing time for receiving bids.

Upon receipt of OWNER's written acceptance of this bid, Bidder will execute the formal contract attached within 15 days and deliver a Surety Bond or Bonds as required by the General Conditions.
